What is TARGPatrol?



- Analytical dashboards and reports to assess the effectiveness of security measures.


What needs does TARGPatrol address?

- TARGPatrol helps efficiently manage security tasks related to patrols, site inspections, and ensuring safety, including assigning checklists and specifying the location and time of execution.
- Checklists **ensure that security personnel follow standards**, with the ability to confirm task completion through photos, videos, or numerical/text data.
- TARGPatrol enhances site security by tracking violations (such as unauthorized access or suspicious activity) within the area.
- The incident registration feature allows staff to quickly report issues—such as attempted break-ins, equipment damage, or other threats—directly through the app.
- The platform provides tools for generating reports and analyzing data, helping assess the performance of security guards and improve safety processes.

How does it work?

- Forming a team in the system (administrators and security guards performing tasks).
- Adding locations and checkpoints where employees will perform tasks.
- Creating checklists for security guards to fill out during inspections.
- Assigning tasks and creating schedules for patrols or shifts.
- Task execution by security guards through the mobile app.
- Viewing and analyzing reports on completed tasks to assess security performance.





How does it work for the performer?

- The security guard logs into the mobile app.
- Then, they **select a task from the list of available ones**, such as patrolling the area or inspecting a site.
- After starting the task, the guard follows the outlined steps and fills out checklists.
- If necessary, they document the result with photos or videos, such as the condition of the secured area or any violations found.
- During the task, the guard can add text comments, such as about suspicious events, and communicate with the administrator if any questions arise.
- Once the task is completed, the guard can review the result of their work and proceed to the next task.

Task Execution Monitoring

THEY HELP WITH TRACKING TASK COMPLETION:


- **Notifications (push, email)** that are triggered by violations or errors found during patrols, as well as when comments are added within a task.
- A schedule that allows real-time tracking of task progress by security guards, including completed steps and checklists.
- Reports providing detailed statistics on ongoing and completed steps in security operations.
- Creation and distribution of newsletters with information on completed tasks.



Analytics

Dashboards, Reports, and Analytics.

- Use **Reports** for different periods to analyze the situation at protected sites, areas, or zones in detail.
- View concise yet key information on the **Dashboard**.
- Use the **Analytics** page to explore structured data in the form of charts and graphs.
- Export all data to other analytics systems for further analysis and security improvements.




Integration
